Regional Development Policy and the Role of State Aid

Background:

The promotion of regional development in the European Union and especially in Greece is of utmost importance to promote social cohesion as well as economic growth. Therefore it is necessary to highlight the role of state aid for safeguarding regional cohesion goals and policies in the EU. Policy objectives and tools as well as the control function of the European Commission and the methodologies it adopts need to be analyzed and critically assessed during the workshop. The impact of state aid on regional disparities will be examined as well as the effect of state aid on regional cohesion goals.

Aims of the Summer Experts Meeting:

The meeting will concentrate academic and administrational expertise on state aid with special focus on aid used for regional development purposes. The debate has two aims: First, the direct contact between academics and practitioners in the field with the benefit of an immediate exchange of views and perspectives. Second, the information of a broader group of decision makers on the results of the debate through a <u>policy paper</u>, which will be concentrating the main findings of the workshop, and which will be disseminated in due course.
